ANNEXURE-A

GENERAL INSTRUCTIONS FOR DOCUMENTS VERIFICATION

1. Candidates have been shortlisted for document verification and Skill Test, based on the performance in Written Test and who are found eligible/conditionally eligible 'provisionally' on the basis of the information filled by them in their application form.
2. Candidates will be required to submit self-attested copies of all documents in support of their claim for eligibility along with originals for verification. Further, in case of any false or incomplete information found/observed with regard to actual eligibility in terms of approved Recruitment Rules, their candidature will be rejected summarily at any stage of recruitment.
3. Candidates are advised to bring the following documents in original, that have to be produced during documents verification. Non-availability of the required original documents may result in disqualification.
 - a. Proof of date of birth.
 - b. Certificates in original in relation to qualification, experience, etc.
 - c. One set of self-attested documents.
 - d. One recent passport size photograph and photo id issued by the competent authority.
 - e. In the case of Govt employee, No Objection Certificate has to be submitted, wherever applicable.
 - f. Candidates belonging to SC/ST/OBC/EWS/PwD should have to produce a certificate in the prescribed form signed by the competent authority concerned.
 - g. Candidates belonging to OBC have to produce the latest caste certificate that he/she doesn't come under creamy layer issued by the concerned competent authority in the prescribed format.
